# Minister's Report: Rev. Cynthia Prescott, Interim Minister

- The UUMAN governing board and minister make use of the "Five Tasks of Interim Ministry" in evaluating progress during the two-year ministerial transition. Here is a summary to date.
  - Task #1: Claim and honor UUMAN's past. Address conflicts that may be holding the congregation back as the transition begins. Many chapters in UUMAN's history graced the "History Wall" in October.
    - Conflict is a learning experience. There is no such thing as a completely conflict-free human community forever and ever, but Rev. Prescott is satisfied that the significant conflicts affecting UUMAN when she arrived were addressed so that the "moving on" could begin.
  - Task #2: Discover UUMAN's unique identity, strengths, needs and challenges. Clarify roles of minister, church staff, lay leaders—and congregation as a whole. Landmarks are hard to identify in this complex ongoing task, but progress thus far is excellent.
  - Task #3: Navigate shifts in leadership that accompany times of transition. Especially noteworthy is the number of new leaders on the coming year's roster of board members, and committee chairs. Many thanks to all of you!
  - o Task #4: Make [renewed] use of Southern Region, Unitarian Universalist Association in Boston and other outside resources. Much of the progress on this task isn't visible to the average congregational eye, but it's happening. Newcomers to the task are welcome.
  - Task #5: Progress toward ultimate transition goal of a renewed vision, strong stewardship, prepared for new growth in numerical and covenantal growth, and for new professional leadership. UUMAN, you are well on track, even a little ahead of schedule. "UUMAN, YOU ROCK"
- UUMAN, you are reaching out to resources available from the UUA and the Southern Region of the UUA.
   You are sending your new President, Anna Swafford, to the UUA General Assembly in Portland, Oregon in June. Others are attending and still others have participated in the most recent Annual Assembly and Finance Workshops.
- Although once UUMAN's search gets officially underway, we take a back seat to the Ministerial Search
  Committee (MSC), the Interim Committee on Ministry (ICOM) is still here to help throughout the rest of the
  transition. They/we are Laurie Wheeler, chair; Julia Fogel, Ben Sample, Sheila Smith, Rev. Cynthia Prescott, ex
  officio.
- Ultimately, "UUMAN, YOU ROCK!"

# **Board Report: John Wheeler, President of the UUMAN Board of Trustees**

- September:
  - o Arrival of Interim Minister, Rev. Cynthia Prescott for two-year Interim period.
  - o Board of Trustees Annual retreat was held at Darya's house with Kirk Bogue as moderator.
    - Goals:
      - Visualize and define where we see UUMAN in two years.
      - Outline how we get there.

- Describe how best to use the talents of Rev. Cynthia Prescott.
- Define how members of the board and staff fit into this picture and how their talents contribute to the goals.
- Identify the support we need to achieve this vision.
- 5 two-year objectives were identified:
  - Embrace the changes necessary for us to be who we say are and to have the impact we want to have in the larger world. -- Healthy Leadership and Organization
  - Ask our larger community what it needs and the answer will inform our social justice commitments. We are "meeting people where they are." -- Justice
  - Expand our worship offerings to meet the needs of those who share our values but seek different types, styles, and times of worship. We will promote 'worshipful' experience.
  - Successfully call a minister who reflects our deep understanding of ourselves -- who we are and where we want to go.
  - Find abundance in our Stewardship to be spilled over to the outside/larger community and our larger faith.

#### October

- Chalice Lighters application was submitted to the UUA Mid-South District by the Playground Committee and approved by the UUMAN board.
- Social Justice Committee developed and Board approved a new policy for vigils and public witness events at UUMAN leading to several public witness vigils for "Black Lives Matter."
- The "five tasks" of interim ministry were clarified.
  - 1. Claiming and honoring the congregation's past, and healing its griefs and conflicts.
  - 2. Illuminating the congregation's unique identity: its strengths, needs, and challenges.
  - 3. Clarifying the multiple dimensions of leadership. Both ordained and lay, and navigating the shifts in leadership that accompany times of transition.
  - 4. Renewing connections with available resources within and beyond the UUA
  - 5. Enabling the congregation to renew its vision, strengthen its stewardship, prepare for new professional leadership, and engage its future with anticipation and zest.

#### November

- UUA Southern Region Congregational Life Consultant, Maggie Lovins, held a workshop at UUMAN about Interim Process and Leadership during our two-year Interim period.
- o Board approved changes to Membership Policy:
  - Changes to process to make more open and less burdensome for UU's joining UUMAN
- First indication that we need a by-laws review.
- Began moving 5 retreat objectives into committees.

#### December

- Began in earnest to get the nominating committee together.
- Minister Assessing where we were with our two-year objectives ahead of where we needed to be.
   Very inclusive.
- o Settled on a modified strategy of the UUA guidance for Minister Search Committee.

# January

- Interim Committee on Ministry was engaged in several tasks:
  - Efforts on explaining Ministerial Search Committee selection.
  - Two-Year Interim Ministry Appraisal thus far.
- Stewardship Cluster Event was held in Alabama.
- North Georgia UU Social Justice Action Cluster Gun Violence Statement was revised and approved by UUMAN board

# Finance Report and Budget for next FY: Kirk Bogue, Treasurer on the UUMAN Board of Trustees

- During the report the following people were recognized for their service to UUMAN Stewardship and the Finance Committee:
  - Carolyn Lee for years of service, especially in the area of bookkeeping and membership on Finance Committee
  - Visiting Stewards and Bob Popp for their leadership and oversight of this year's pledge canvass
  - o For the Finance Committee Jan Wilson, Rick Irwin, Michelle Liebergesell and Rosie Popp helping bring increased fiscal responsibility to UUMAN
- Three opportunities for members to discuss thoughts and ideas or share feedback regarding "THERE" or solutions to budget plans were announced:
  - Thursday, May 21, 7:00pm, Fellowship Hall (regular Finance Committee Meeting)
  - Sunday, May 24, after service in the Sanctuary Discussion Group-meet with members of Finance Committee
  - Sunday, May 31, after service in the Sanctuary Discussion Group-meet with members of the Finance Committee
- The main messages conveyed regarding UUMAN Finances at the Congregational Meeting centered around the question "Are We There Yet?". THERE was described as a place of confidence about our community and financial health, which includes:
  - Enabling our minister search team to find and attract the best minister candidate possible. It would be reflected by a generous membership (which we are), 2-3 months of operating cash in the bank (not there, but we are healthier financially than we've been in awhile),
  - A budget that supports the new minister <u>and</u> our staff with fair share compensation
  - The money to relocate the minister we want
  - The notion that our new minister will not have to feel his/her own income/well being is threatened frequently, at least not at the outset
  - Reserves for capital expenses.... Zero fundraisers dedicated to the operating budget and more to social justice
  - O Having people on hand to help with a financial situation that arises (income or expense variance)

- Draft Budget was handed out: See attached draft budget at the end of this document.
- We discussed that this year's budget isn't finished, that we likely need to solve an approximately \$20,000 income challenge:
  - Fundraisers? A call for extra funds? Some other approach?
  - We're not sure yet which approach is best for the ways that people like to be generous when they
    can).
  - We noted that this \$20,000 challenge is virtually annually recurring, and that we always find a way to manage it.
- We also noted that we won't solve the recurring cycle through cutting bits and pieces of expense items.
  - We solve this by
    - Sustaining a higher level of membership -or-
    - Reducing the one expense item that consumes a lot of our resource, our mortgage.
      - It was noted that reducing our \$556,000 mortgage by even 25%-30% would essentially eliminate this \$20,000 challenge we currently face.
- We noted that we are stewards together at UUMAN.
  - o This is not "them" asking for something.
  - This is us, the people we sit next to on Sunday, discussing our situation tougher.
  - We are abundant in our ideas and resourceful in solving problems we name.
  - We are closer than ever to being THERE than ever before.
  - Ideas are forming, you can help shape them.

# Ministry of Children and Youth (MCY): Toniann Read, Director of Ministry of Children and Youth (DMCY)

- UUMAN Mission Statement: We come together to create an environment that celebrates our differences, nurtures transformative growth, and promotes an open-minded search for truth and justice both within our walls and beyond.
- MCY Vision & Mission Statement: Within UUMAN's MCY, we picture an intentional community with people of all ages, where we can change and grow by being together lovingly and thoughtfully.
  - Our mission is to be together in ways that affirm our UU Principles. The different programs &
    activities that we create in our shared ministry give us many choices for growing and exploring with
    each other.
  - Our goal is to build a ministry that focuses on connecting deeply with others. We will help each other learn and grow and celebrate each person's unique personality & gifts. We will take care of one another and our whole community.
  - We will always do our best to create a physically and emotionally safe church home where UU
     Principles can be both lived and demonstrated.
  - We welcome everyone in our congregation to share our ministry by worshipping, playing, serving, learning, & growing together.
- 2014-15 Theme/Focus: Continuing our journey towards building a ministry where everyone matters.
  - Our focus this year has been 'neurodiversity', or the idea that our minds work/process in many different ways, some more typical than others.
  - Our goal is embracing, celebrating and understanding our learning differences...none of us are 'broken' or in need of fixing.
  - We are committed to meeting the needs of an increasingly diverse community of learners/explorers.

- We are researching ways that we can build more flexibility into the Sunday morning RE sessions (curricula) that we are planning to offer next year.
- Numbers/Data:
  - 74 children & Youth registered
  - Average Sunday morning attendance fluctuated over the course of the year, from highs in the high 50's to lows in the low 30's.
  - 40+ Adult Sunday Morning RE Volunteers
- MCY Council: We currently have openings for MCY Vision Coordinator and Secretary/Communications Coordinator on the council. Please see Kathy or Toniann if you would like to know more.
- The role of the community in the Faith Development of young people
  - Staff:
    - Toniann Read is completing her 12<sup>th</sup> year with UUMAN, and is thankful everyday for the joy of serving alongside the members of this community.
    - Sue Hagood is in her 10<sup>th</sup> year as Nursery childcare provider at UUMAN, where she
      offers devoted attention to our youngest children and their families. We couldn't be
      more grateful for the gift of her loving ministry.
    - Preschool Leader: We are still seeking to fill this position
- Highlights!
  - Religious Exploration (RE): Under the guidance of Carolina Patlis Friedman, the RE Associates worked together during the 2014-2015 RE year to provide a welcoming, friendly, organized and open space for RE volunteers, students and visitors. Merri Beth Stephens has coordinated a team to manage resources, and has been available as support for RE volunteers.
  - We helped young people sign in for RE, distributed materials to the volunteers, and greeted visitors and answered their questions.
  - We kept track of weekly attendance, by filing all the weekly sign-up sheets and keeping a tally of young people and adults. Attendance has been fluctuating since August of 2014, it started with a full roster of students and weekly visitors and continued for several weeks, declining towards the end of the year to about half the original count.
  - We ensured that all sessions were covered by 2 adults at all times and we escorted visitors to their respective rooms.
  - We made sure that all young people returned to their parents or caregivers at the end of RE, either by having parents go down to the classrooms for pick up or by bringing the young people to the RE table to wait for their parents.
  - We washed and put away all snack containers and cups at the end of each RE session.
  - General organization goes well, volunteers report on time, sessions start on time. Challenges have been to get the sign-up sheets back from teachers at a timely manner after class, to get all the parents and students to sign their names in the sheets before class, some parents take their kids directly to the classroom.
  - Weekly subs have been on site and helpful when there were vacancies. We were unsuccessful in acquiring a pre-school teacher this year, although we had one qualified candidate who applied. This should be top of our list for next fiscal year.

- The summer program for 2015 is fully staffed and will be starting on 6/6/15 with tie dye fun. Merri Beth Stephens will be facilitating this process over the summer.
- Our Whole Lives: we are proud to say that as of this fall, UUMAN now offers all levels (K-12) of this comprehensive sexuality program. We are steadily moving towards our goal of offering comprehensive sexuality education across the lifespan. We are extremely grateful for the dedication and significant time commitment of our OWL facilitators.
- Family Ministry: Kara Sweeney continues to coordinate Family Ministry, which has regular monthly gatherings with a potluck and parent meeting. Our meetings have covered a wide range of topics this year and continue to address the most pressing emotional issues that face our caregivers. Attendance has been good this year, although could always improve.
  - Playgroup is transitioning this year, with Kara having stepped down from her role as
    the dedicated facilitator. Work needs to continue next year to re-establish the group
    and set its intentions. Without a clear leadership structure, the playgroup will likely
    be unable to continue. We have attempted to find a facilitator without success. The
    group still meets but is sporadic and not consistently meeting the needs of its
    members.
- Social Action: Steve Smith had led us through another full and fun year of social action. The year began with Trick or Treat for Unicef, on to the IRC Thanksgiving Dinner for Refugee families, and the youth's stocking project for Lost 'N Found Youth. 2015 got off to a great start with us participating in the Martin Luther King Jr. March in Atlanta in January that the kids always love. Public witness in events like this gives them the opportunity to experience activism on a larger scale and in a diverse setting.
- We also participated in several roadside vigils in support of the #BlackLivesMatter movement that the kids both made signs for and participated in.
- Chalice Circle Sundays continued to be a favorite as the kids get to explore different aspects of social justice through a variety of activities including a delightful outing to Arbor Terrace retirement home this Spring. These experiences teach important lessons about fairness, equitable relationships and justice.
- The kids' participation in our new Faith In Action Sundays was wonderful because they had the opportunity to choose to participate in "adult" activities alongside the grown-ups, which was a real empowerment for them. Maya Henson did a wonderful job leading the adults in a Guided Meditation action station that was a big hit, as was Maeve Hubbard's duck tape bag making station. Lucas Begley (age 5) led a paper plant pot activity...we were all so proud of his leadership!
- Worship: This has been a year of innovation and experilearning in the worship component of our ministry. One of our goals going in to this year was to work on our multigenerational worship experience. We have tried some new things, learned some useful lessons, and experienced some beautiful worship for all ages.
  - We close the 2015 Worship year with some great news. Duco Van Der Beek will be
    moving into a the role as Youth Worship Associate beginning in August. Additionally,
    according to the feedback we have been receiving, we can call our Faith in Action
    Sundays a HUGE SUCCESS. Randy Blasch will be working more closely with the
    Worship Associates in 2015/16 on making them even more inclusive as far as
    participation.

- Youth Adult Committee: It has been exciting to watch the youth group take back some of their programming, and lead so enthusiastically. Highlights are the Thanksgiving Dinner for the International Rescue Committee, and this holiday's Faith In Action for Lost & Found Youth...digging the rainbow tree!! Many thanks to Suzy Rezelman who did an awesome job supporting the youth as they re-establish their leadership structure.
- MCY Council: under Kathy Hubbard's leadership, monthly meetings are the highlight of the MCY calendar. This group is mission driven and deeply principled as they guide and care for all of UUMAN's ministry with children and youth. We also want to thank Amy Scovill for keeping great minutes, as the council secretary.

    - As long as we continue to offer alternative forms of voting for those who are not on the internet, it's a real plus.
    - Difficulties with e-voting were related to misspellings and mistakes on our database.
      - This helps us to clean up database.
      - Customer service was swift.
    - The safety of our ballot with e-voting is the same as with our proxy ballot system. In both cases a member could fraudulently vote by using another's name.
      - Do we think this is happening?
      - We are in covenant with each other and are unaware of any ballot tampering
