The Need for Solar: Georgia's Energy Systems

- Well over the majority of our energy production comes from Natural Gas and Coal.
- The harvesting, shipping, and burning of these materials for energy is killing us and our neighbors faster.
- We cannot afford to simply wait for them to change.
- We can shift some of this on our own buildings, while also increasing our disaster resilience. It is worth the effort and the risk.

Divestment

- Divestment is tangible, and perhaps the most impactful thing we can do to create change.
- \$700,000,000,000 invested in fossil fuel companies from investment banks since the Paris Climate Agreement.
- We need to move our money. We need to move our congregation's money. We need to move our denomination's money.

- Divestment in a non-violent, creative solution that actually produces practical and systemic change.

Not far from Waste Management's R&B Landfill in Banks County, the company parks a fleet of special side-dumping trailers and trucks in Franklin County. The big rigs—loaded with toxic coal ash—create a steady I-85 convoy out of the Carolinas.

Policy Opportunities on Coal Ash

- Register at **Protectgeorgia.org** for advocacy and policy updates.
- SB 123 calls for the increase in tipping fees to be equal with household garbage.
- HB 756 Calls for the removal of all coal ash and requires it all to be stored in dry, lined landfills.

100% Clean and Equitable Energy Policies

- We will likely never get a 100% clean energy at the state level, or a renewable portfolio standard.
- We can achieve virtually the same goal by implementing 100% clean energy plans at the local and city levels across this state.
- Currently Atlanta, Athens, and Clarkston have Clean Energy goals.
- We are hoping to push the same in Decatur, Savannah, Columbus, Macon, and more, this year.
- This can be local, city, and state level.
