UUMAN's Board of Trustees uses <u>Covid Act Now</u> to monitor current Covid risk levels. In 2022, the site adopted a 3-tier system for communicating risk.

A member of the Board will monitor the website on a weekly basis to determine the current risk levels.

- If ALL of UUMAN's catchment counties (Cherokee, Cobb, DeKalb, Forsyth, Fulton, Gwinnett) are Low Risk, or green category, AND there are fewer than 15 cases in the past 14 days and <5% positivity rate per <u>Georgia Department of Public Health status report</u>, then UUMAN will be considered Fully Open with no restrictions.
- If Fulton or Cobb counties (the 2 counties where the largest percentage of our congregation lives) are **Low Risk**, or green category, then masks are optional for indoor and outdoor activities. Indoor congregational singing can occur at this time.
- If Fulton or Cobb counties (the 2 counties where the largest percentage of our congregation lives) are **Moderate Risk**, or yellow category, then masks are required for indoor activities. Indoor congregational singing cannot take place at this time.
- If Fulton or Cobb counties (the 2 counties where the largest percentage of our congregation lives) are **High Risk**, or orange category, then masks are required for indoor activities. Indoor congregational singing cannot take place at this time. In addition, leave at least one seat in between families and groups that share housing.

Suggested language for posting across all communication channels:

Fully Open Message: UUMAN's Board of Trustees uses <u>Covid Act Now</u> and the <u>Georgia Department of</u> <u>Public Health status report</u> to monitor current Covid risk levels. We are beyond thrilled to see that the counties in which we live are all in the Low Risk category, AND that we've had fewer than 15 cases in the past 14 days and <5% positivity rate. UUMAN is considered **FULLY OPEN** at this time, **with no restrictions in place for Covid**. We are happy to say that UUMAN's community continues to be highly vaccinated and boosted—thank you for doing your part to keep our risk as low as possible!

Low Risk Message: UUMAN's Board of Trustees uses <u>Covid Act Now</u> to monitor current Covid risk levels. We are thrilled to see that the counties in which the majority of us live are in the Low Risk category. Masks are optional for indoor activities, and indoor congregational singing can occur at this time. We are happy to say that UUMAN's community is highly vaccinated and boosted—thank you for doing your part to keep our risk as low as possible!

Moderate Risk Message: UUMAN's Board of Trustees uses <u>Covid Act Now</u> to monitor current Covid risk levels. At least one of the counties in which the majority of us live is currently in the Moderate Risk category. **Masks are required for indoor activities**, and indoor congregational singing cannot take place.



We are happy to say that UUMAN's community is highly vaccinated and boosted—thank you for doing your part to keep our risk as low as possible!

High Risk Message: UUMAN's Board of Trustees uses <u>Covid Act Now</u> to monitor current Covid risk levels. At least one of the counties in which the majority of us live is currently in the High Risk category. **Masks are required for indoor activities**, and indoor singing cannot take place at this time. Practice social distancing by leaving at least one seat between families and groups that share housing. Your Board will continue to monitor the trends weekly and will update this message as soon as we're able. We are happy to say that UUMAN's community is highly vaccinated and boosted—thank you for doing your part to keep our risk as low as possible!
